The purpose of this addendum is to modify the solicitation identified as **2025-06 Suspended Backstop Netting System** (“Solicitation”) to reflect the change(s) identified and described below.

Applicable Addendum Category:

- Modify bid opening date and time
- Modify specifications of product or service being sought

Description of Modification to Solicitation:

Modify **Section 3.1.1.5.1** from a total of approximately 513 linear feet to approximately 640 linear feet.

Modify **Section 3.1.1.5.2** from an overall height of approximately 30’ AGL to 20’ AGL.

Add Section 3.1.1.6 to the Specification to add 8 door cut-outs, four on each side, 6 feet each at the bottom of the steps for field access.

Additional Documentation: Documentation related to this Addendum (if any) has been included herewith and is specifically incorporated herein by reference.

Terms and Conditions:

1. All provisions of the Solicitation and other addenda not modified herein shall remain in full force and effect.

Q:1 Please confirm the required completion dates of the project.

A:1 As stated in Section 3.2.1 of the Solicitation: All Netting must be installed and completed during the week of April 20 through April 27, 2025, or between June 16 through June 26, 2025. The April date is the preferred date.

Q:2 What is the total linear footage of the required Netting System?

A:2 The total linear footage of the Netting System is 640 feet.

Q:3 What is the height of the Netting?

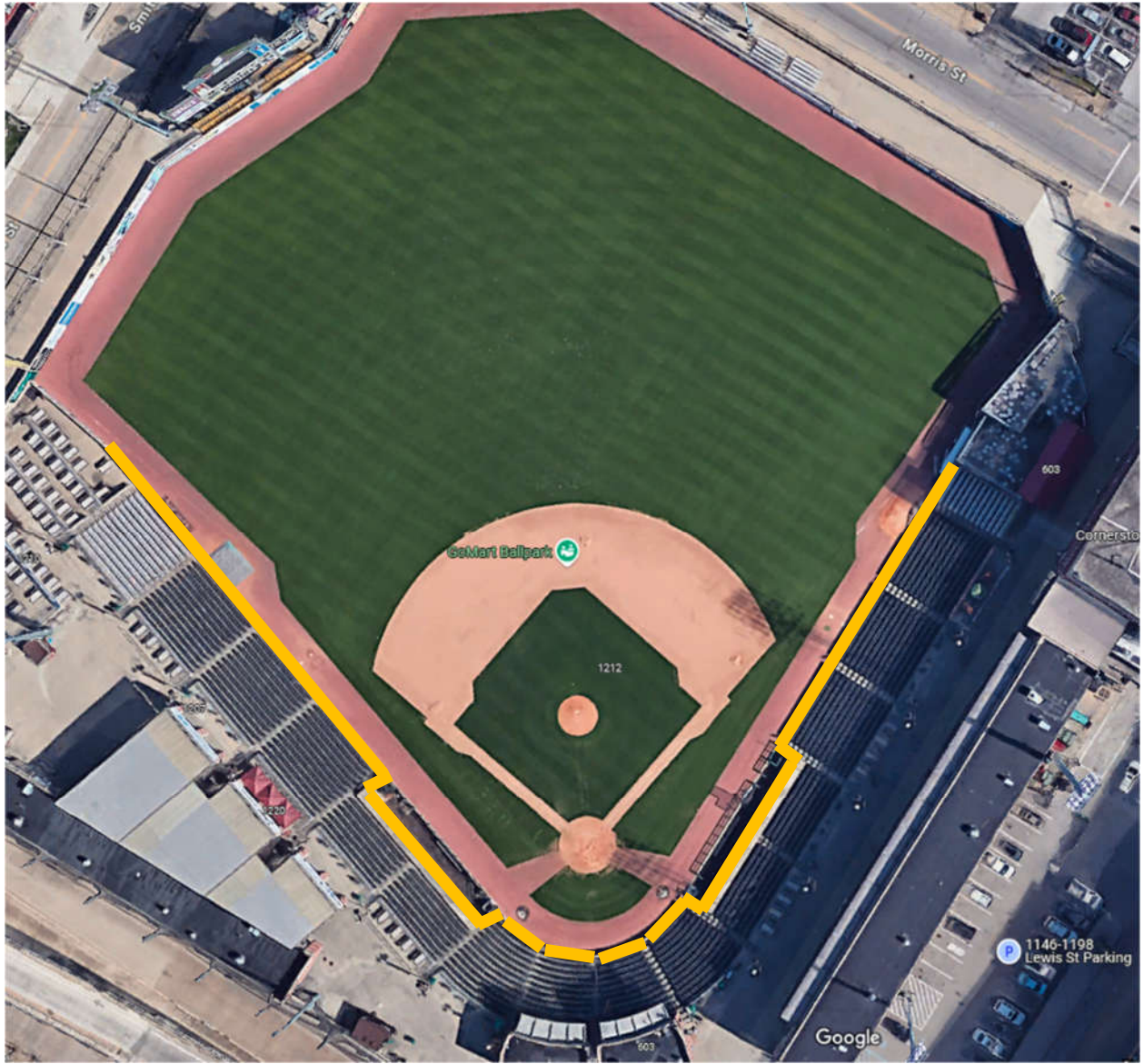
A:3 The Netting is 20 feet high.

Q:4 What size are the squares on the netting?

A:4 The squares should be 1-inch squares.

Q:5 Will there be any doors cut into the Netting?

A:5 Yes, there will be a total of 8 doors to be placed at the bottom of the steps for field access. Four doors on each side, six feet each. The doors have been added by this addendum in Section 3.1.1.6 of the Specifications.
