Questions and Answers

Q1: Would coating the roof be an option?

A1: Yes, roof coating is explicitly permitted as an alternative solution, pursuant to the following provisions:

- All bids **MUST** include pricing for removal and replacement of the existing roof pursuant to the specifications in the Bid documents.
- All bids **MAY** include as an alternative proposal pricing for a spray or roll-on coating of the existing roof.
- The coating material presented in any alternative solution must meet industry standards for this type of work and **must include a minimum 10-year warranty** for both material and workmanship.
- The City reserves the right to award **EITHER** the low bid on the removal and replacement by comparing the bids provided for this option, **OR** the low bid on the alternative solution of coating the existing roof by comparing the bids provided for this option.
- To be clear, if the City chooses to award the removal and replacement, it reserves the right to reject all bids for the alternative solution in their entirety, even if these options are a lower cost, and award the low-bid of the removal and replacement of the existing roof.

Q2: Will the electric be moved to install the roof material?

A2: Yes. The City and the staff of Sojourner's Shelter have spoken with AEP, who will be coordinating the removal and reattachment of the electrical supply.

O3: Will the stairs be removed before the roof is installed?

A3: Yes. The City is planning for the removal of the existing wooden stairs prior to the roof repairs, and is also planning to replace these stairs upon completion of the work.

A4: Bids must be received in the City Manager's office no later than Tuesday, August 12, at 2:00pm
