The number of deliveries per year varies, so a quantity of two was used to establish a competitive bid price. There will not be a guaranteed number of deliveries or tonnage.

Q2: Will the Certificate of Insurance need to be submitted as part of the bid, or can it be submitted upon award?

A2: The City does prefer that the COI be submitted with the bid to expedite evaluations. However, it is not a cause for immediate disqualification.
